Some important details-

Costs: Course tuition for the Clinical Mentoring Program is \$1550 per year for each of the three years. Payment in full, or arrangements for a payment plan, must be completed by the start of each year's program in September. *This rate includes tuition and meals for the fall Mentoring Workshop—if that meeting needs to be held online, instead of in-person, then a revised tuition rate for the year will be announced in July or August.*

Participation: The foundation year webinar teaching/discussion sessions will take place on Thursday evenings at 8:30pm EST/5:30pm PST, with planned meetings on Sept. 2, Sept. 30, Oct. 21, Dec. 2, Jan. 20, Feb. 10, March 3, 24, April 14 and May 26. These sessions are built around interactive teaching and small group discussion. Therefore, live attendance and participation in at least 80% of the live sessions is required for successful completion of the Foundation Year course (with independent work submitted for sessions which were missed). Please include these dates in your calendar planning.

The Clinical Mentoring Workshop, which we hope will take place October 28-31, 2021 in Denver, CO, *will be an onsite event that you are expected to attend in person.* If the coronavirus pandemic prohibits travel or group meetings, then we will switch to an online format, but you should plan to join us in Denver as the very elements we hope to highlight (history and physical examination, development of a therapeutic plan) cannot be taught as effectively in a digital format.

Cancellation: Application means that you are applying to join a three-year course. If you recognize this is not the right course of study, you may cancel your registration up until October 15th and receive a tuition refund, minus a \$250 administrative fee. No refunds will be given after October 15th. We do recognize that unexpected life events happen, so requests for postponement (taking a "gap year") may be considered on a case-by-case basis. These must be approved by the course director.
